LOUIS R. BARBATO teaches courses in contemporary drama and Shakespeare at Cleveland State University. A recipient of grants from NEH and the Folger Shakespeare Library, Dr. Barbato has also taught at the University of Delaware and the University of Cincinnati. His articles have appeared in *Philological Quarterly*, Shakespeare Jahrbuch (Weimar), and Shakespeare Bulletin.
