

Appendix D – Interview Guide

These are questions for a semi-structured interview. They are intended to indicate the themes to be discussed at each interview. Given the nature of semi-structured interviews, follow-up 'probe' questions depend very much on the answers received to the initial questions, as well as on the results of the concurrent analysis of previous interviews. Therefore, it is expected that these questions will vary across interviews. This is standard procedure in many types of qualitative research.

 - f. How comfortable would you feel reaching out to your partner in the future for advice or to set up an elective?
 - g. How interested are you in doing an elective or placement abroad?
