Studying Women at Home and Abroad: A Bibliographic Guide to English-Language Sources, 1970 - 1982.*

Within the past dozen years or so, long-overdue and wide spread recognition of and interest in women's special situation has contributed to a flood of literature recovering their past and assessing their contemporary, position, roles, oppression and options. Thanks in large part to a rebirth of feminist activism, women are now emerging to take their place in scholarly literature. Critical to appreciating these developments are a host of recent bibliographic guides to old and new records on women. Collectively, these provide a critical map to the expanding world of women's studies. Like the bibliographies themselves, this guide to recent English-language bibliographies is intended to be a road map of sorts for enquiring educators and researchers unfamiliar with work on women outside their area of expertise or new to the interdisciplinary field of women's studies. While not all reference works could be consulted, this guide covers many of the available, interdisciplinary guides to women's studies in general and offers a sampling of the more useful disciplinary guides on women. Although a selection of English-language guides to women in Europe has been cited, the particular focus is on women of five countries: Australia, Britain, Canada, New Zealand and the United States.

The criteria for selection is fairly straightforward. English-language bibliographies published between 1970 and 1982 were scanned first for their scope and useful annotations, secondly for their inclusion of new or original material and finally for their organizational strengths. Not all the items eventually listed, however met the standards originally anticipated. The level of bibliographic scholarship fluctuated tremendously both in quantity and quality. Disciplinary contributions were typical. The relative abundance of critical guides to women's history, for example, allows a reasonable degree of selectivity. Choosing bibliographies on women and politics, on the other hand, given the dearth of these source guides, demands a less critical eye. Much bibliographic work clearly remains before a balance can be reached. One useful spin-off of this guide might be its identification, albeit indirect, of the gaps which need to be addressed.

The items selected for this compilation are arranged alphabetically under broad subject headings. These headings clearly do not exhaust the wide range of topics which together make-up women's studies but they indicate the areas of major concentration in the English-language literature. The exclusion of such concerns as women and religion, for example, like the inclusion of women and employment, reflect to a significant degree the current "state of the question" in the five nations.

The preponderance of North American material, particularly that published in the United States, while in part a reflection of the writer's access to sources, also exposes an imbalance in the amount of scholarly work produced within the English-speaking societies under consultation. The pathbreaking role American investigators have played in the study of women stands out in this guide.

A few additional comments regarding selection are worth noting. First, because of their recent publication dates or their absence from British Columbia libraries, there are a few unannotated or scantily annotated sources which were not reviewed at length. Their titles did, however, suggest potential usefulness and have therefore been identified for further reference. Guides to women's studies in New Zealand, for example, were especially hard to track down and can only be mentioned in brief. Secondly, the research and preparation of this bibliography have been informed by reviews, brief abstracts in periodicals, as well as other major bibliographies. These sources have guided selection and influenced annotations. When appropriate, they are, of course, noted at the end of the entry. Thirdly a geographical arrangement of sources has been rejected since the scope of many of the

works cited transgressed national boundaries. Subject categories seemed, as shall be seen, more appropriate.

Bibliographies of Bibliographies

1. Ballou, Patricia. *Women, A Bibliography of Bibliographies*. Boston: G.K. Hall, 1980, 155 pp.

This interdisciplinary volume lists 557 sources published between 1970 and 1979. All except 28 items are annotated and the topics range from literature and philosophy to sex-roles and abortion. Books, parts of books, journal articles and microfilms, as well as bibliographic essays, literary reviews, library catalogs, and guides to archives and manuscripts are covered. See *Choice*, Vol. 18, April 1981, p. 1067, and *Library Journal*, Vol. 105, November 15, 1980, p. 2378.

2. Eichler, Margrit. *An Annotated Selected Bibliography of Bibliographies on Women*. Ottawa: Association of Universities and Colleges Canada, 1973.

Though dated, the evaluative annotations and the inclusion of somewhat obscure source guides make this bibliography of bibliographies a worthwhile introductory tool.

3. Ritchie, Maureen. *Women's Studies: A Checklist of Bibliographies*. London: Mansell Publications, 1980. \$23.50

The introduction notes: ". . . information about the existence of bibliographies rather than an assessment from the compilers' point of view is what is needed at this level of bibliographic control" p.x. Ritchie chooses not to annotate the 489 entries. With American sources, there are a number of Canadian and British citations. Several Australian guides are included. 4. Williamson, Jane. *New Feminist Scholarship: A Guide to Bibliographies*. Old Westbury, New York: Feminist Press, 1979, 139 pp. \$15.00

. . . represents one of the first major attempts to organize and classify women's studies bibliographies. Helpful annotations describe the comprehensiveness and limitations of 52% of the 391 entries. While Williamson attempts to demonstrate the scope and quantity of English-language bibliographic work, she concentrates heavily on material from the United States. Inter-disciplinary Guides and Inventories

1. Bettison, Margaret. *Her Story: Australian Women in Print, 1788-1975*. Sydney: Hale and Iremonger, 1980, 181 pp.

An expanded version of Anne Summers 1973 compilation issued in the first three issues of the *Refractory Girl, Her Story* "originated from a feminist perspective on Australian women [and attempts] to cover as wide as possible a range of subject areas of interest to feminists" (introduction). Entries are organized under 22 subject categories ranging from feminist theory to violence to attitudes toward women. Author index.

2. *Books on Women: A Selection of Titles in the Auckland Public Library for International Women's Year*. Auckland, New Zealand: Auckland Public Library, 1975.

Four folders include entries covering the women's movement, women's history, women at work and women as wives and mothers.

3. Bunkle, Phillida and Beryle Hughes (eds.). *Women in New Zealand Society*. Auckland; London: Allen and Unwin 1980, 265 pp.

This collection of articles addressing women in politics, women in professions, women and work, women artists, women's education, women's sexuality and women writers cites significant sources within each of these subject areas.

4. Cambridge Women's Studies Group. *Women in Society: Interdisciplinary Essays*. London: Virago, 1981, 320 pp. 4.95

The essays in this anthology concentrate on four areas: women as workers in capitalist society; politics and sexuality; mental illness and health; theories of sexual differences. The authors' range of disciplines include anthropology, psychology, semiology, history, politics and sociology. See *British Book News*, January 1982, p. 21.

5. Cates Dodson, Suzanne (ed.). *Microform Research Collections: A Guide*. Westport, Connecticut, 1978.

An updated edition of this guide is forthcoming in 1983.

6. Davis, Audrey B. *Bibliography on Women: With Special Emphasis on Their Roles in Science and Society*. New York: Science History Publications, 1974, 50 pp. \$3.00

"The purpose of this selection is to show the numerous possibilities for locating research material on the roles and accomplishments of women and attitudes toward them" (intro.) These sources which were drawn from the Library of Congress Catalogue, 1950 to March 1973, include other wise hard to find titles on women's role in industry, science and on the frontier. 7. Een, Jo Ann D. and Marie Rosenberg-Dishman. *Women and Society, Citations 3601 to 6000: An Annotated Bibliography*. Beverly Hills, Calif.: Sage, 1978. 277 pp.

This updated expansion of a 1975 publication of the same title offers a cross-cultural, international guide to over 3000 sources. Titles are organized under headings ranging from economics, politics, law and the military to medicine, philosophy and literature and the arts. Annotations are very brief but informative. Ample indexing. See *Choice*, Vol. 12, January 1976, p. 1426, and *Library Journal*, November 1975, p. 2037.

The 477 unannotated entries in this compilation fall under the following categories: General Family; Birth Planning; Labour Market; Law; Education; Social Problems; Social Psychology; Women's Organizations' Women's Movement; Misc. The selection are cross-referenced and there is an author index.

8. Froschl, Merle and Jane Williamson. *Feminist Resources for Schools and Colleges: A Guide to Curricular Materials*. 2nd ed. revised. Feminist Press, 1977.

Updating the first edition by Carol Ahlun and Jacqueline Fralley, this bibliography is an inclusive yet selective guide to non-sexist books, pamphlets, articles and other materials for teachers from pre-school through higher education.

9. Eichler, Margritt and Lynne Primrose. "A Bibliography of Materials on Canadian Women Pertinent to the Social Sciences and Published Between 1950 and 1972." In Marylee Stephenson (ed.) *Women in Canada*, Toronto: New Press, 1973, pp. 291-331.

10. Haber, Barbara. *Women in America: A Guide to Books, 1963-1975: With an appendix on books published, 1976-1979*. Urbana: University of Illinois Press, 1981. 262 pp.

Haber begins by documenting the women's movement and the state of publishing on women's issues from 1963 to 1975. In addition to evaluative annotations she provides lengthy reviews of two or three of what she considers to be the most important works on each topic. Non-fiction works are emphasized.

11. Harrison, Cynthia. *Women's Movement Media: A Source Guide*. Bowker, 1975, 269 pp. \$13.75

This is a compendium of American sources. Includes chapters on publishers, distributors, news services and products, women's research centers, women's organizations, governmental and quasi-governmental agencies and special interests ranging from civil rights to social welfare. Ample indexing. See *Choice*, Vol. 12, October 1975, p. 980, and *Library Journal*, Vol. 100, July 1, 1975, p. 1111.

12. Hauck, Philomena. *Sourcebook on Canadian Women*. Ottawa: Canadian Library Association, 1979, 111 pp.

Hauck writes lengthy descriptive and evaluative annotations on sources which are organized under the following headings: Women's Rights, Women and the Law, Work and Day Care, Health and Fitness, Biographies, Literature By and For Women, Books for Liberated Children, Periodicals, Audiovisual Materials, and General Bibliographies and Information Sources.

13. Heinz, Neil. *Women in New Zealand: A List of Material Issued 1950-1978*. Auckland: Auckland University Library, 1980, 106 pp.

This list of books and articles in the principal New Zealand journals is arranged alphabetically under subject headings. Author title index.

14. Higgins, Susan and Jill Matthews. "For the Record: Feminist Publications in Australia Since 1975." *Meanjin*, Vol. 38 (3), 1979, pp. 321-333.

15. Hughes, Marija Matich. *The Sexual Barrier: Legal, Medical, Economic and Social Aspects of Sex Discrimination*. Washington, D.C.: Hughes Press, 1977, 843 pp. \$40.00

... lists English-language materials, published during 1960 to 1975. Its fairly comprehensive coverage of law materials and extensive coverage of medical literature are its most attractive features. No subject index. See *Choice*, Vol. 15, April 1978, p. 208; and *Library Journal*, Vol. 103, February 15, 1978, p. 449

16. Jacobs, Sue Ellen. *Women in Perspective: A Guide to Cross-Cultural Studies*. Urbana: University of Illinois Press, 1974, 299 pp.

Part one is organized geographically by continent and country. Part two covers subject areas of particular interest to anthropologists, psychologists and social and political-scientists. Includes monographics and articles published between the turn of the century and 1974. A few are briefly annotated; most are not. See *Choice*, Vol. 12, March 1975, p. 50; and *Library Journal*, Vol. 100, March 1, 1975, p. 467.

17. Krichman, Albert. *The Women's Movement in the Seventies: An International English Language Bibliography*. Metuchen, New Jersey: Scarecrow, 1977, \$30.00.

Over 8,600 books, pamphlets, PhD dissertations, research reports, government documents and periodicals, all published or reprinted from 1970 to 1976 make up this international guide. 93 countries are represented although 2/3 of the material deals with the United States. Subject categories range from culture and literature to sociology and anthropology. See *Booklist*, Vol. 75, November 1, 1978, p. 345; and *RQ*, Vol. 18, Spring 1979, p. 311.

18. McKee, Kathleen Burke. *Women's Studies: A Guide to Reference Sources*. Storrs, Connecticut: University of Connecticut Library, 1977, 112 pp. \$5.00.

The 364 items in this reference guide are arranged by type of publication, ie. handbooks, directories, statistics etc. The annotations explain the purpose, arrangement and use of the sources in women's studies research. See *Choice*, Vol. 15, April 1978, p. 208, and *College and Research Libraries*, Vol. 39 (2), March 1978, p. 147.

19. Mazur, Carol and Sheila Pepper. *Women in Canada, 1965 to 1975: A Bibliography* 2nd Ed., Hamilton: McMaster University Library Press, 1976, 174 pp.

. . . an updated and expanded version of Cynthia Harrison's 1972 compilation, *Women in Canada, 1965 to 1972: A Bibliography*. Almost 2,000 unannotated citations cover materials exclusively on Canadian women and are arranged under approximately 300 subject headings.

20. Nordquist, Joan. *Audiovisuals for Women*. Jefferson, North, Carolina: Folkestone, 1980, 145 pp. \$8.95.

Audiovisuals for Women is intended to update Cynthia Harrison's *Women's Movement Media* and Helen Wheeler's *Womanhood Media* and its supplement. In contrast to these standard works, it also offers separate sections on 16 mm film, videotape, filmstrips, slides and recordings, both spoken and music. In many of the entries presents quotes from major review sources are included.

21. Oakley, Ann *Subject Women*. Oxford: Robertson, 1981.

The fifty page unannotated bibliography in this examination of women's studies includes titles covering themes from feminist questions to women's labour, relationships, and power and women's studies.

22. Oakes, Elizabeth and Kathleen E. Sheldon. *A Guide to Social Science Resources in Women's Studies*. Santa Barbara, Calif.: ABC-Clio, 1978, 162 pp. \$19.25.

A critical assessment of essential social science materials on women, gathered from a broad range of sources from anthropology, economics, history, psychology, sociology and contemporary feminist thought. The annotations describe the content of and thesis of the resource and critically evaluate it in terms of its use as an undergraduate text. The guide has an unusually heavy emphasis on international materials. See *Choice*, Vol. 16, April 1979, p. 207; and *Resources for Feminist Research*, Vol. 9 (1), March 1980, p. 21.

23. O'Connor Blumhage, Kathleen and Walter D. Johnson (eds.). *Women's Studies: An Interdisciplinary Collection*. Westport, Connecticut: Greenwood, 1978, 142 pp.

The bibliographies of the eleven essays in this edited collection are helpful guides to both interdisciplinary and disciplinary materials in the social sciences. Also includes a separate 12 page bibliographic guide to social science literature.

24. Roberts, Helen (ed.), *Doing Feminist Research*. London: Routhledge and Kegan Paul, 1981, 207 pp. \$9.50.

Critiques of empirical research and the problems with research conceptualization/qualitative research from a perspective of British sociology and feminism. The sources cited are for the most part limited to literature published in Britain. See *Choice*, Vol. 19, November 1981, p. 450.

25. Seymour, Rosemary. *Women's Studies in New Zealand, 1974-1977: a Pilot Bibliography-Directory*. Hamilton: University of Waikato, 1978, 554 pp. \$7.00 (N.Z.).

Seymour's introductory guide includes material in preparation and details of women's studies courses, collections on women and women's organizations.

26. Stineman, Esther. *Women's Studies: A Recommended Core Bibliography*. Littleton, Colorado: Libraries Unlimited, 1979.

Each entry in this comprehensive core collection of 1,763 English-language imprint "women-related" publications addresses the source's content and organization, its relevance to the field of

women's studies, its originality, and the author's perspective (feminist or not) and approach to the subject. See *Resources for Feminist Research*, Vol. 10 (2), July 1981, p. 110; *Choice*, Vol. 17, April 1980, p. 206; and *R.Q.*, Vol. 19, Winter 1979, p. 185.

27. Terris, Virginia, R. *Women in America: A Guide to Information Sources*. Detroit: Gale, 1980, 520 pp. \$26.00

The purpose is to "suggest the possibilities for research into the lives of American women". Organized under 10 broad chapter headings, the almost 2,500 items listed include general reference material as well as more specific works on topics ranging from Women's Role, Image and Status to Women in the Arts. Separate author, title and subject index.

28. United Nations Secretariat. *Status of Women, A Selected Bibliography*. New York: United Nations, 1975, 121 pp.

Concentrating on works published between 1965 and 1975, primarily from the collection in the Dag Hammarskjold Library, *Status of Women* is divided by topics and further sub-divided by geographical location. Lists all relevant United Nations, material and many non-Western publications. See *Choice* Vol. 14 January, 1978, p. 1483 and Elizabeth Oakes, *A Guide to Social Science Resources in Women's Studies*, Santa Barbara: ABC-Clio, 1978, p. 141.

29. Warren, Mary Anne. *The Nature of Woman: An Encyclopedia and Guide to Literature*. Inverness, California: Edgepress, 1980, 708 pp.

"This book attempts to bring together in one volume an overview of the considerable literature, particularly from philosophy and the social sciences, on the nature of woman. It provides an introduction to the arguments and conclusions about this topic of a wide range of Western thinkers, from Plato, Aristotle and the authors of Genesis to the feminists and antifeminists of the 1970's," (p.1). The book functions as a guide to the literature as well as to ideas. Its main body is followed by annotations on 150 anthologies and source books which are presented in topical clusters. 30. Wheeler, Helen R. *Womanhood Media Supplement: Additional Current Resources About Women*. London: Scarecrow, 1975, 482 pp. \$15.00.

A guide supplement to an earlier publication, *Womanhood in Media: Current Resources About Women* (1972). It is divided into book, non-book and source directory sections intended to chart women's past and present conditions. This second volume expands listings on affirmative action, the arts, Canadians, Latinas, lesbians and the media. See *Choice*, Vol. 13 (2), April 1976, p. 208.

31. Woodsworth, Anne. *Women: A Guide to Bibliographic Sources*. Toronto: University of Toronto, 1974. 26 pp.

Woodsworth presents brief but evaluative annotations of bibliographic source guides available at the University of Toronto Library. Bibliographies, biographic sources, course syllabi, dictionaries and lexicons and some journals are included. Subject and author index.

Guides to Archival Source

1. Barrow, Margaret. *Women 1870-1928: A Select Guide to Printed and Archival Sources in the United Kingdom*. London; New York: Mansell, 1981.

"... to lead the researcher to the relevant collections of archival material and to indicate the scope of the material available." p. xii. An introduction precedes each of its four parts: Archives, Printed Works, Non-Book Material, and Libraries and Record Offices, outlining the full scope and range of materials as well as the criteria and methods of selection and the arrangement. Subject, author, title indexes.

2. Daniels, Kay et al.. *Women in Australia: An Annotated Guide to Records*. Canberra: Australian Government Publications Services, 1977, 2 Volumes.

Primary sources which "reveal the experience of women within society and which reveal their position within social processes" (introduction) are cited in this introductory guide to Australian manuscript holdings and records. The entries are ordered first by location and then by the holding body.

3. Deutrich, Mabel and Virginia Purdy (eds.). *Clio Was a Woman: Studies on the History of American Women*. Washington, D.C.: Howard University Press, 1980, 352 pp.

This volume of conference proceedings reflects and presents a wide range of materials available for the study of women in the National Archives in Washington. See *Choice*, Vol. 18, September, 1980, p. 156, and *American Archivist*, Vol. 43, Fall 1980, p. 493.

4. Hale, Linda Louise. *Selected Bibliography of Manuscripts and Pamphlets Pertaining to Women, Held by Archives, Libraries, Museums and Associations in B.C.* Toronto: Ontario Institute for Studies in Education, 1978, 200 pp.

A comprehensive inventory of the resources in British Columbia which contains women's history sources.

5. Hinding, Andrea (ed.). *Women's History Sources: A Guide to Archives and Manuscript Collections in the United States*. New York: Bowker, 1980, 2 Volumes.

The main volume of this massive compilation arranges over 18,000 collections of unpublished primary source materials pertaining to American women, alphabetically by state, city, institution, repository and then by collection. Each entry includes a brief description of the content as well as the collection's title, physical description, access format and bibliographic format. The second volume provides a comprehensive index to the materials in the first.

6. Light, Beth. *Sources in Women's History at the Public Archives of Ontario*. Canadian Women's History Series #1. Toronto: Ontario Institute for Studies in Education, 1977.

Personal papers, family papers, manuscript collections public records, pamphlet collections and miscellaneous collections are cited in this compilation of primary sources on Canadian women held in the Public Archives in Ontario.

7. Reed, Janet and Kathleen Oakes. *Women in Australian Society: A Guide to the Holdings of Australian Archives Relating to Women, 1901-1945*. Canberra: Australian Government Publication Services, 1977.

A comprehensive, annotated listing of primary sources which offer insight into Australian women's history.

8. Reilly, Heather and Marilyn Hindmarch. *Some Sources for Women's History in the Public Archives of Canada*. Mercury Series, History Division Paper, no. 5. Ottawa: National Museum of Man, 1974.

Outlines and annotates English-language documents in the Public Archives of Canada, drawn exclusively from 19th and 20th century personal papers.

History

1. Common Women Collective. *Women in United States History: An Annotated Bibliography*. Cambridge, Massachusetts: Common Women Collective, 1976, 114 pp.

Written from a feminist and radical political perspectives with critical annotations covering topics ranging from colonial women to social reform, the depression to women at work. Useful for the introductory level and high school courses. See Elizabeth Oakes and Kathleen Sheldon *A Guide to Social Science Resources in Women's Studies*. Santa Barbara, California: ABC-Clio, 1978, p. 135.

2. Danielas, Kay and Mary Murnane. *Uphill all the Way: A Documentary History of Women in Australia*. St. Lucie, Queensland: University of Queensland Press, 1980, 355 pp.

Divided into four parts: Outcasts of Society; Private Lives; Working Women; Women and Politics, *Uphill all the Way* is a useful, introductory source guide to primary literature. A listing of the location of these documents is also included.

3. Evans, Richard. *The Feminists: Women's Emancipation Movements in Europe, America, Australia. 1840-1940*. London: Croom Held, 1977.

Includes a useful bibliography of major sources on the history of feminism on all three continents.

4. Goodwater, Leanna. *Women in Antiquity: An Annotated Bibliography*. Metuchen, New Jersey: Scarecrow, 1975.

Books and articles in major European languages cited with emphasis on English works and translations. Divided into ancient and modern works, most sources are annotated. A great many older and forgotten pieces are brought to light. See *Choice*, Vol. 13, January 1976, p. 496, and *Library Journal*, April 15, 1976, p. 998.

5. Harrison, Cynthia (ed.). *Women in American History: A Bibliography*. Santa Barbara, California: ABC-Clio, 1979, 374 pp. \$78.00.

A compilation of 3,395 abstracts of articles from 550 journals and 5 anthologies published between 1963 and 1976. Harrison has selected those dealing the "the full range of women's experience in the United States and Canada" (preface). The organization is both chronological and topical. Subject and author indexes. See *RQ*, Vol. 19, Summer 1980, p. 399.

6. Kanner, Barbara. *The Women of England: From Anglo-Saxon Time to the Present: Interpretive Bibliographic Essays*. Hamden, Connecticut: Archon, 1979, 429 pp.

The twelve essays and appended bibliographies in this volume covering women in Anglo-Saxon society to women in the 20th century, "confirm that there is a history of the women's history of England" (introduction). The various essays suggest how the sources may be employed in teaching and writing. See *Choice*, Vol. 16, February 1980, p. 1636, and *RQ*, Vol. 19, Spring 1980, p. 303.

7. _____" The Women of England in a Century of Social Change, 1814-1914, Part II" in Martha Vicinus (ed.) *A Widening Sphere: Changing Roles of Victorian Women*. Bloomington: Indiana University Press, 1977, pp. 173-226.

Compliments Kanner's selected bibliography of the same title in Vicinus' 1972 publication *Suffer and Be Still: Women in the Victorian Age*. The first guide aimed at "providing a useful catalogue for studying the social [public] position of women in England during the 19th Century" (introduction). This concentrates on private experiences. Organized chronologically under broad subject headings.

8. Kelly, Joan et al.. *Bibliography in the History of European Women*. Bronxville, New York: Sarah Lawrence College, 1976.

A comprehensive guide to largely American sources organized chronologically and according to subject. Entries unannotated, subjects include: General Reference Materials; Historiography; History of Women; Antiquity, the Middle Ages, Renaissance and Reformation, Modernity; in 17th and 18th Century Europe and Industrial Society.

9. Lerner, Gerda (ed.). *The Female Experience: An American Documentary*. Indianapolis: Bobbs-Merril, 1977, 509 pp.

A guide to documents in women's history, Lerner as well as pays attention to conceptualizing women's history by studies on the female life cycle. See *Choice*, Vol. 14, July 1977, p. 749.

10. Light, Beth and Veronica Strong-Boag. *True Daughters of the North: Canadian Women's History: An Annotated Bibliography*. Toronto: Ontario Institute for Studies in Education Press, 1980, 210 pp.

True Daughters of the North presents a thorough review of both primary and secondary literature on "women's experiences and role in the creation of the modern Canadian community" (introduction). The over 1,000 entries are divided into five sections: General References; New France; British North America; Canada, 1867-1917; Post-World War One Canada. Author index.

11. O'Faolain, Julia and Lauro Martines (eds.). *Not in God's Image: Women in History From the Greeks to the Victorians*. New York: Harper and Row, 1973.

A wide-ranging source collection which, though dated, includes literature which is difficult to find such as material on witch trials and Byzantine and medieval law.

12. Reimer, Eleanor and John Fout (eds.). *European Women: A Documentary History, 1789-1945*. New York: Schocken, 1980, 258 pp. \$6.95.

Fifty-three documents focussing on "women's experiences, aspirations and consciousness" (p. xiii) in Western and Central Europe and Russia. A 14 page bibliography is a valuable resource.

13. Rowbotham, Sheila. *Women's Liberation and Revolution: A Bibliography, 1972*. London: Falling Wall Press, 1973, 24 pp.

"This bibliography lists books, pamphlets and articles which explore the relationship between feminism and revolutionary politics" (preface). The items selected include topics ranging from general feminist history to spiritualism. Brief annotations.

14. Teale, Ruth (ed.). *Colonial Eve: Source on Women in Australia 1788-1914*. Melbourne; New York: Oxford University Press, 1978, 288 pp.

Abstracts of literature about women's status and opportunities during the "Convict Era, 1788-1850" and during the "Victorian Era, 1850-1914". See *Reference Services Review*, Vol. 7, April 1979, p. 6.

Employment and Education

1. Armstrong, Douglas & Marian Dwaraczek. *Women: A Bibliography of Materials Held in the Research Library*. Toronto: Ontario Ministry of Labour Research Library, 1974, 81 pp.

The approximately 900 sources included in this bibliography on women and employment are divided into two sections — books, and periodical articles. The unannotated, alphabetically ordered, entries represent primarily English-language publications from Canada, Britain and the United States.

2. Bickner, Mei Liang and Marlene Shaughnessy. *Women At Work: An Annotated Bibliography*. Vol. 2. Los Angeles: University of California, 1977, \$7.50.

Covers seven topics: general, history, education, training, working women, occupations, special group, public group, Evaluative annotations.

3. Faunce, Patricia Spencer. *Women and Ambition: A Bibliography*. Metuchen, New Jersey: Scarecrow, 1980, 659 pp. \$35.50.

This fairly comprehensive, unannotated bibliography of approximately 10,000 citations, focuses on recent contributions (1960-1976) in the field of women's achievement motivation and women's ambition. The items are arranged alphabetically in broad categories such as "societal forces" or "career development". No subject index. See *Choice*, Vol. 18, November 1980, p. 372.

4. Frank, Genevieve. *Women at Work and in Society: A Selected Bibliography, 1970-1975*. Geneva: International Institute for Labour Studies, 1976, 38 pp.

Includes English and French unannotated entries arranged under eight subject headings: Labour Force Participation of Women; Motivation, Job Satisfaction; Careers; Division of Work Between Sexes; Work and Family (Relation Between Paid and Unpaid Work); Educator's and Training; Women and Decision-Making; Women's Role in the Economy; Women & Society. Author Index.

5. Haist, Dianne. *Equal Pay for Work of Equal Value: A Selected Bibliography*. Toronto: Ontario Ministry of Labour Research Library, 1976. 15 pp.

An introduction to the "state of the question" in Canada, the United States and Great Britain. Also includes some literature addressing international approaches.

6. _____." *Women in Management: A Selected Bibliography, 1970-1975*. Toronto: Ontario Ministry of Labour Research Library, 1976.

An unannotated compilation of monographs, articles, periodicals and bibliographies which address Canadian and American research on and issues in women and management.

7. Kohen, Andrew. *Women and the Economy: A Bibliography and a Review of the Literature on Sex Differentiation in the Labour Market*. Ohio: Ohio State University, 1975, 88 pp.

Prepared for the United States Department of Labour, 500 unannotated citations fall under 27 categories and cover topics such as women and unionism and home production and child care. An evaluative bibliographic article entitled, "Sex Differentiation and the Labour Market: A Review of the Literature" closes the report.

8. Matthews, Catherine and Marnie Shea. *Affirmative Action: A Selected Bibliography*. Toronto: Ontario Ministry of Labour Research Library, 1975. 17 pp.

The books and periodical articles cited in this introductory guide are unannotated, organized alphabetically and cover American, British and Canadian material.

9. Parker, Franklin and Betty Jane Parker. *Women's Education — A World View: Annotated Bibliography of Doctoral Dissertations*. Westport, Connecticut: Greenwood Press, 1979, 470 pp.

All English-language American and Canadian theses on women's education included in the following sources: Comprehensive Dissertation Index; Dissertation Abstracts International; Contributions to Education; Digests of Dissertations (Teacher's College Columbia); Berkeley Library; and a variety of specialized bibliographies, were abstracted in this publication. Arranged alphabetically with a subject index.

10. Pask, Judith. *The Emerging Role of Women in Management: A Bibliography*. West Lafayette, Indiana: Purdue University, 1976.

The materials included are limited to those focussing on women managers in the business world. Organized by publication format and subject groupings, the guide is intended to be a research tool and to demonstrate the wide range of materials available on women in management" (introduction). Unannotated.

11. _____." *Women and the Economy: A Selected Bibliography*. West Lafayette, Indiana: Purdue University, March 1977.

Topics covered in this bibliography include: Career Planning and Development; Money Management; and Women in the Working World (politics, role models, non-traditional fields). Unannotated.

12. Phelps, Ann et al. *New Career Options for Women: A Selected Annotated Bibliography*. New York: Human Sciences Press, 1977, 144 pp.

Part of a three-part series designed for counsellors, counsellor trainers and those in women's studies. (See Helen Farmer and Thomas Becker, *Career Options: A Woman's Guide* (1977) and *New Career Options for A Counsellor's Sourcebook* (1977).) Abstracts 240 selected American and international research from 1970's.

13. Soltow, Martha and Mary K. Wery. *American Women and the Labour Movement, 1825-1974: An Annotated Bibliography*. Metuchen, New Jersey: Scarecrow, 1976. 247 pp.

This collection underlines the role women have played over the course of United States Labour History. It includes books, monographs, journal articles, pamphlets and United States government documents. The 726 annotated listings are arranged under eight subject heading. An appendix of archival collections in the United States.

14. Williams, Martha et al.. *Women in Management: A Selected Bibliography*. Austin: Centre for Social Work, University of Texas, 1977. 64 pp.

Eight topical areas on legal issues, organization, change strategies. Articles cited on barriers to and about female leadership.

15. *Women and Work: An Inventory of Research*. Ottawa: Canadian Research Institute for the Advancement of Women, 1978. 85 pp.

A brief essay by the members of the CRIAW publishing committee and six editorials on the state of the research in this area introduce this inventory. Seven categories include: Women and Work; Paid Work; Unpaid Work; Unemployment; Education for Work; and Images, Myths and Stereotypes. Author Index.

16. *Women and Work in U.S. History: An Annotated Selected Bibliography*. Washington, D.C.: Business and Professional Women's Foundation, 1976, 28 pp.

A concise annotated bibliography of sources, both in monograph and article form on the history of women's work. 105 items are ordered under four categories: Methods and Theory in Women's History; Earlier Scholarship; Contemporary Scholarship; and Guides to Further Resources.

17. Yanz, Linda. "Women and Unions — A Bibliography"; Smith, David, "Women and Trade Unions: A Guide to Primary Source Material"; and Luce, Sally R. and Kristen Ostling, "Women and White Collar Unions: An Annotated Bibliography" in *Resources for Feminist Research*, Vol. 10 (2), July 1981, p. 85-106.

While some reference to international source materials is offered, these guides focus primarily on Canadian trade union literature.

Politics and Law

1. *Bibliography: Women in Canadian Politics*. Ottawa: Women's Bureau, Labour Canada. March 1980.

238 unannotated items, including books and article are listed under four categories: General; Federal; Provincial and Municipal.

2. Evans, Gwynneth. *Women in Federal Politics: A Bio-Bibliography*. Ottawa: National Library of Canada. 1975.

"The aim of the present bio-bibliography is to present a short biographical sketch of each women senator or member, to list some of the sources of this information, and to provide a selected list of the subject's publications, where relevant." (preface) The main arrangement is chronological with senators listed first.

3. Levanson, Rosaline. *Women in Government and Politics. A Bibliography of American and Foreign sources*. Monticello, Illinois: Council of Planning Librarians, 1973, 80 pp.

American publications since 1940 are emphasized in this guide to women in government and politics. Asian, Canadian, European, British, Indian, Latin America and Middle Eastern, English-language publications do receive coverage in its fourth major section: Women in Politics and Government in Other Countries.

4. Stanwick, Kathy. *The Political Participation of Women in the United States: A Selected Bibliography 1950-1976*. Metuchen, New Jersey: Scarecrow, 1977, \$6.50.

Intended as a tool for organizing scattered resources and indentifying gaps in the literature on women's political activity, this bibliography includes more than 1500 entries representing materials produced from 1950 to 1976. Women's political activity and activism. See *R.Q.*, Vol. 18, Fall 1978, p. 105.

5. Service, Dorothy Jane. *Women and the Law: A Bibliography of Materials in the University law Library*. 2nd edition. Toronto: University of Toronto, 1978, 80 pp. \$7.50.

A second edition to compliment Service's earlier compilation without duplication. The citations fall under four categories: monographs, articles in Canadian legal journals, articles in non-Canadian legal journals, and continuations — looseleaf services, journal reports.

6. MacKnolty, Judy and Heather Radi (eds.). *In Pursuit of Justice: Australian Women and the Law, 1788-1979*. Sydney, Australia: Hale and Iremonger, 1980, 328 pp. \$9.95 (Aust.).

This collection of 22 essays addresses women's legal rights and interests from the convict days to the 1970s citing historical and legal sources with a list of over 450 items of discriminatory legislation. See *Resources for Feminist Research*, Vol. 10 (11), March 1981, p. 88.

Past and Current Feminist Issues: Divorce, Health, Reproduction, Sexuality, Sex-Roles and Violence Against Women

1. *Abortion Bibliography for 1980*. Troy, New York: The Whitston Publishing Co., 1982.

“*Abortion Bibliography* is the 11th annual list of books and article surrounding the subject of abortion in the preceding year. It appears serially each fall as a contribution towards documenting in one place as comprehensively as possible the literature on one of our central social issues.” (preface)

2. Astin, Helen et al.. *Sex Roles: A Research Bibliography*. Rockville, Maryland: National Institute for Mental Health, 1975, 362 pp.

Annotates books, articles and papers largely published from 1960 to 1972 examining observed sex differences and sex role theory. Subject/Author index.

3. Bullough, Vern L. et al. *A Bibliography on Prostitution*. New York: Garland, 1977, 419 pp. \$19.00

A comprehensive guide to 5494 works on prostitution.

4. Carey, Emily. *Issues in the Psychology and Counselling of Women: Additional Resources*. Boston: Womanspace, 1976.

Supplements an earlier guide by Carey et al. entitled: *Counselling Women: A Bibliography*. The three new categories included are: women and alcoholism, lesbians and mental health. See *Resources for Feminist Research*, Vol. 9 (2), July 1980, p. 87.

5. _____." *New Resources*. Boston: Womanspace, 1979. 44 pp.

Updates a 29 page bibliography, *Women: Sexuality, Psychology and Psychotherapy* (A Bibliography) (1976). the sources are partially annotated and include discussion of domestic violence, ethnicity and counselling. See *Resources for Feminist Research*, Vol. 9 (2), July 1980, p. 87.

6. Chaff, Sandra et al.. *Women in Medicine: A Bibliography of the Literature on Women Physicians*. Metuchen, New Jersey: Scarecrow, 1977, 1124 pp. \$35.00

Provides a comprehensive coverage of the literature about women physicians in all parts of the world. Annotated entries which include journal articles, books reports and published speeches are arranged under 14 subject categories and cover a 226 year period (1750-1975). See *Booklist*, Vol 76, November 1, 1979, p. 458.

7. Chalfant, Paul et al.. *Social and Behavioral Aspects of Female Alcoholism: An Annotated Bibliography*. Westport, Connecticut; London: Greenwood Press, 1980. 145 pp.

The 488 abstracts of journal articles within this guide offer a fairly complete coverage of the periodical material addressing female alcoholism primarily in the 1970s. Author index.

8. Clark, Lorene and Simon Armstrong. *A Rape Bibliography With Special Emphasis on Rape in Canada*. Ottawa: Research Division, Solicitor General of Canada, 1979. 130 pp.

This guide is an updated and revised version of Duncan Chappel et al.'s, *Forcible Rape: Bibliography*. The addition of a section on recent rape research in Canada makes it particularly useful to Canadian researchers. Sociology, the Law, and Police Investigation are but a few of the topics included under a subject arrangement.

9. *Divorce: A Bibliographic Look At The World*. Ottawa: Health and Welfare Canada, Departmental Library Services, 1977.

The citations trace the development of present attitudes to divorce and divorce law reform. Unannotated, they are arranged topically under two major sections: Divorce and the Individual; Divorce by Continent and Geographical Area.

10. Doughan, David. *Birth Control: The Equal Knowledge Campaign 1922-1931: A Select Bibliography*. London: LLRS Pub., 1981, 23 pp.

11. Friedman, Leslie. *Sex-Role Stereotyping in the Mass Media: An Annotated Bibliography*. New York: Garland, 1977, 324 pp.

A survey of a wide range of literature about negative images of women in airline ads, comic strips, daytime programs and pornographic literature. See Maureen Ritchie *Women's Studies: A Checklist of Bibliographies*. London: Mansell Publ., 1980, p. 470.

12. Gottlieb, Naomi (ed.). *New Knowledge About Women: A Selected Annotated Bibliography for the Human Behavior and Social Environment Curriculum in Social Work Education*. New York: Council on Social Work Education, 1981, 45 pp.

13. Hirsh, Miriam F. *Women and Violence*. New York; London: Van Nostrand Reinhold, 1981. 385 pp.

A synthesis of extensive research, this book provides an in-depth exploration of rape, incest, prostitution, crime and wife battering. Though unannotated, it is a valuable introductory tool. See *Choice*, Vol. 18, June 1981, p. 1488, and *Library Journal*, Vol. 106, April 15, 1981, p. 895.

14. Hill, Cheryl. *Women and Health: A Select Annotated Bibliography*. Wellington, New Zealand: Committee on Women, 1980, 32 pp.

The entries focus on women's health and hygiene. Arranged under subject headings, each is briefly annotated.

15. McKenny, Marby. *Divorce: A Selected Annotated Bibliography*. Metuchen, New Jersey: Scarecrow Press, 1975, 157 pp. \$6.00

Subject areas ranging from General and Historical Works to Literature and Film are included in this attempt to cover "every significant writing on divorce in English through 1972". (preface) The

materials are almost completely restricted to the United States although one chapter presents a few preliminary works or popular articles on divorce published in Europe, Asia, the Commonwealth and Latin America.

16. Resnick, Gary. *An Annotated Bibliography of Current Research on Rape and Other Sexual Offences*. Toronto: Ontario Provincial Secretariat For Justice, December 1979, 94 pp.

This comprehensive examination of Canadian studies on rape and other sexual offences also includes and extensive sampling of significant American studies, as well as research from other countries. Thoroughly annotated entries are organized under the several categories. See *Resources for Feminist Research*, Vol. 9 (2), July 1980, p. 88

17. Schlesinger, Benjamin. *The One-Parent Family: Perspective and Annotated Bibliography*. 4th edition. Toronto; London: University of Toronto Press, 1978.

Reviews recent studies primarily conducted in Canada, the United States and Great Britain. The literature included covers families headed by fathers, widows, un-married women, and single-parents who have adopted children. A review of literature dealing with children and divorce is a new feature of this 4th edition. See *Children Today*, March 1979, p. 31, and *Library Journal*, Vol. 104, February 1, 1979, p. 394.

18. Sell, Kenneth and Betty Sell. *Divorce in the United States, Canada and Great Britain: A Guide to Information Sources*. Detroit: Gale Research, 1978.

"This interdisciplinary guide directs the general users, graduate or undergraduate student, scholar, educator, clinician or researcher to retrospective, current and continuing sources of information on divorce." (preface) An addendum updates this bibliography to April 1978. Name, title and subject indexes.

19. Walstedt, Joyce. *The Psychology of Women: A Partially Annotated Bibliography*. Pittsburgh, Pennsylvania: International Standard Book, 1972. 76 pp.

Almost 600 citations are arranged under the following categories: Infancy and Childhood; Adolescence; Young Adulthood; Middle and Old Age; Cross-Cultural; General Source Material; Primate Studies; Minority Group Status; Psychoanalytic Theories; Sexuality and Physiology. Most entries are annotated.

20. *Women and Mental Health: A Selective Bibliography, 1965-1975*. Ottawa: Department of National Health and Welfare, Departmental Library Services, 1976.

21. *Women and Psychology*. Cambridge, Massachusetts: Cambridge-Goddard Graduate School of Social Change, 1972.

"[This] is a selected bibliography based on readings that we as feminists found useful for the issues and questions to which we addressed ourselves" (introduction). Each section is preceded by an introduction describing how the materials were selected and used.
